The annual meeting of the Lake Metigoshe Recreation Service District (LMRSD) is held for the benefit of all Lake Metigoshe property owners. This is your opportunity to be apprised as to how LMRSD operates and conducts business. We will review last year's projects and provide you with further plans for any new expansion.

The LMRSD Board of Directors consists of nine members. Each year three Directors are elected for a three year term. A membership committee (appointed by the Board) will present a slate of candidates for election to the vacant positions. **Any property owner within the boundaries of the LMRSD district, who would like to be a candidate for a board position, should contact one of the directors, or choose to be nominated from the floor during the annual election.** Voter ID required. Regular monthly meetings are held at 10 AM on the second Saturday of each month at the LMRSD office.

## LAKE METIGOSHE RECREATION SERVICE DISTRICT GARBAGE REGULATIONS

All garbage must be out by 7:00 AM Monday morning for pickup. **Exceptions: Monday holidays, garbage pickup will then be on Tuesday morning starting at 7:00 AM.**

**HOUSEHOLD GARBAGE MUST BE IN PLASTIC GARBAGE BAGS, SECURELY TIED, AND PLACED IN A COVERED ANIMAL PROOF CONTAINER! CARDBOARD BOXES CANNOT BE USED AS CONTAINERS FOR HOUSEHOLD GARBAGE. No container's over 35 lbs. No construction or inert materials.**

**EPA regulations** require household garbage to be placed in containers separate from grass clippings, leaves, lake-weed, etc. Grass clipping, leaves, lake-weed, etc., properly bagged and securely tied in plastic bags will also be collected. Bags containing wood, cement, dirt, metal, ashes, or other prohibited substances will not be collected. **Lake-weed must be dried before bagging!**

**STATE AND FEDERAL REGULATIONS** require that the following items **are not** to be collected:

PAINTS/PESTICIDES	SOLVENTS	SLUDGES	FUELS
ASPHALT SHINGLES	WASTE OIL	OLD BATTERIES	LUMBER
ANIMAL MANURE	DEAD ANIMALS	ACIDS /ALKALINES	TIRES

**EPA regulations also require the disposal of the following at approved disposal sites:**

STOVES	WASHING MACHINES
DRYERS	FREEZERS
REFIGERATORS	AIR-CONDITIONERS
FURNACES	WATER HEATERS

These types of items may be disposed of at an approved site in the City of Bottineau: **Ketterling's Junkyard (228-2412), or the City of Bottineau landfill (228-3668 or 228-3620).**

### 2016 SPRING AND FALL CLEANUP

**A dumpster will be provided on Sunday, May 29<sup>th</sup> & Monday May 30<sup>th</sup>, and on Sunday, September 4<sup>th</sup> & Monday September 5<sup>th</sup>. The hours will be from 10 AM until 6 PM at the LMRSD parking lot.**

**This dumpster is for the disposal of normal spring and fall cleanup material. Household garbage and construction material are not allowed.**

**THIS SITE WILL BE MONITORED AND THE DUMPSTER WILL BE REMOVED AFTER 6:00 PM EACH DAY. IF THE DUMPSTER IS FULL, PLEASE DO NOT PILE YOUR TRASH NEXT TO THE DUMPSTER. A REPLACEMENT WILL ARRIVE SHORTLY.**

## NOTICE

### USE OF PUBLIC SEWERS AND GARBAGE COLLECTION SERVICES

Assessments for sewer and garbage services are based on the number of connections to the LMRSD sewer system. Each connection generates a separate assessment. It is the responsibility of the property owner(s) to notify the LMRSD if it is the intention of the owner(s) to remove one or more connections to the sewer system and thus terminate the assessment for each such connection. This is necessary so that charges for services are maintained current and accurate. When LMRSD is notified of an owner(s) intention to terminate services, LMRSD maintenance employees shall certify that the structure(s) have been removed and that any waste water collection facilities that were used in connection with said structure(s) have been properly capped to prevent future use.

**Inert Pit Hours:** 9:00 AM – 5:00 PM on Tuesday, Friday, and Saturday. The pit opens May 3rd and will remain open through October 1<sup>st</sup> during the above listed hours. An attendant will be on duty. No Sunday dumping (except by special arrangement). All other dumping - by appointment only.
