Agenda:

Kathy Garbe made a motion to approve the agenda. Allen Boettcher seconded the motion. All in favor. Motion carried.

Minutes:

Val Zwak made a motion to approve the November 12, 2022 minutes as emailed. Verdell Lund seconded the motion. All in favor. Motion carried.

Financial report: Chad Strand

Mike McIntee made a motion to approve the monthly financials and pay the bills as presented. Allen Boettcher seconded the motion. All in favor. Motion carried.

Mike McIntee made a motion to transfer \$835.49 from the General Fund to the Replacement Fund as per budget to end the year with \$500 in that fund. Kathy Garbe seconded the motion. All in favor. Motion carried.

Operations Report: Mike Hall

- Gridbee Mixer Machine A new one would cost \$51,200. Mike found some refurbished mixers located in Big Sky, Montana for \$34,218 each. *Kathy Garbe made a motion to purchase two Gridbee Mixers from the Lagoon Expansion Fund at a cost of \$68,436 installed.* Allen Boettcher seconded the motion. All in favor. Motion carried.
- Fixed broken line by Hahns and added a double-ball check.
- Birchwood grease trap visited with owners and assisted them cleaning instructions.
- Christian Center grease trap LMRSD staff cleaned the old trap and made sure it was installed correctly.

The grease trap in the new addition still has not been installed as per the letter sent by LMRSD attorney on September 20, 2022. That letter addressed requiring the installation of a grease trap in the new addition and to be inspected by Mike Hall. The new trap still has not been installed.

Mike McIntee made a motion to send a bill to the Metigoshe Christian Center for \$3,000 (\$100/day for the month of November) as per the September 20, 2022 letter for failure to comply with the conditions outlined therein. The letter drafted by attorney Hartl will set a date of February 1, 2023 to pay the penalty of \$3,000 and install the grease trap in the new addition. Payment of the penalty alone will not remove the requirement to install the grease trap. Failure to comply with installation of the grease trap will necessitate that the LMRSD board move forward with disconnection of the sewer. Compliance in full, however, with the

- newly installed grease trap by February 1, 2023 and inspected by Mike Hall would prompt the board to consider removal of the \$3,000 penalty and subsequent \$100/day accrual. Val Zwak seconded the motion. All in favor. Motion carried.
- Ulteig Engineering timeline: Plans submitted to LMRSD and health department in January. Project bid requesting would begin in February. March would be the award month and material order by the General contractor.
