Mike McIntee discussed bathroom/vault toilet at pickleball court.

Mike McIntee made a motion to have our attorney send a letter to the ND Attorney General requesting an opinion. Does LMRSD, which has more restrictive rules than the State or County, have final authority on decision of vault bathroom at pickleball court. Brian Jensen seconded the motion. Motion carried.
